**RESOLUTION**

A RESOLUTION concerning

Maryland-National Capital Park and Planning Commission

Capital Budget for Fiscal Year 1994-1995

For the purpose of amending the Prince George's County portion of the Maryland-National Capital Park and Planning Commission Capital Budget for Fiscal Year 1994-1995 to add appropriation authority to the Prince George's Baseball Stadium.

WHEREAS, Article 28, Section 2-118, of the Annotated Code of Maryland provides for the amendment of the Capital Budget of the Maryland-National Capital Park and Planning Commission (the "Commission") by the County Governing Body on its own initiative or at the request of the Commission and after public hearing upon reasonable notice to the public; and

WHEREAS, the Commission has requested an amendment to the Prince George's County portion of the Commission's Capital Budget for FY 1994- 1995, as adopted by CB-46-1994, to add funding authority for the Prince George's Baseball Stadium project (CIP ID #EC040932) in the amount of \$793,500; and

WHEREAS, the Commission has identified \$793,500 in the Stadium Reserve account in the Recreation Fund as the source of funding for the amendment; and

WHEREAS, the Prince George's Baseball Stadium was approved in the FY 1993 Capital Budget, as adopted by CB-46-1992 and amended by CB-67-1993, in the amount of \$9,000,000; and

WHEREAS, funding for this project was provided by the State of Maryland, developer

contributions, and the Commission, and it has been determined that there is a need for expanded parking; and

WHEREAS, the funding of \$793,500 will be reimbursed by revenue generated from a fee charged for parking at the stadium; and

WHEREAS, the County Executive has recommended to the County Council such amendment; and

WHEREAS, the County Council has conducted a public hearing on the proposed amendment having given reasonable notice thereof.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1994--1995 Maryland-National Capital Park and Planning Commission Capital Budget is revised to include the Prince George's Baseball Stadium as shown in Attachment "A" attached hereto and made a part thereof.

BE IT FURTHER RESOLVED that the Fiscal Year 1994-1995 Capital Budget of the Maryland-National Capital Park and Planning Commission, as adopted by CB-46-1993, Appendix B, is hereby amended to increase the amount in the Commission's Capital Budget by \$793,500 in accordance with the following schedule:

BE IT FURTHER RESOLVED that Fiscal Year 1995 funds for this project shall be derived from the Stadium Reserve account in the Recreation Fund.

BE IT FURTHER RESOLVED, that the Stadium Reserve account shall be abolished, and after following two years of parking revenue collection to be utilized for parking lot construction, future parking revenue shall be returned to the Recreation Fund.
