<u>BIKEWAYS</u> for the purpose of providing for the authority regarding motorized vehicles on sidewalks or trails; providing for certain fines; providing for prohibiting motorized vehicles on bike lanes and bikeways with certain exceptions and generally regarding the prohibition with exceptions of motor vehicles on sidewalks, trails, bike lanes and bikeways.
