BACKGROUND INFORMATION/FISCAL IMPACT:

This bill prohibits parking, standing and/or selling vehicles on certain roads, areas and spaces. This bill provides that parking and/or selling or offering for sale of vehicles on public roads, County property and/or in the County right of way is prohibited. This bill prohibits unlicensed dealers that sell vehicles and requires vehicle registration. This bill deals with the use of For Sale signs. Further, this bill prohibits the standing or parking of vehicles on an unpaved area of a residential lot.
