This resolution approves amendments to the Recreation Fund within the FY 2026 Operating Budget for the Maryland-National Capital Park and Planning Commission (M-NCPPC). Specifically, this resolution amends the approved project charge funding for four organizations providing recreation programming within Prince George's County to reflect the changing needs of these organizations.

On May 29, 2025, the County Council, by the approval of CB-055-2025, adopted the M-NCPPC FY 2026 Operating Budget. The adopted budget set aside \$14.7 million from the Recreation Fund to support community-based recreation programming through project charges to eligible organizations. In response to changes in the community's recreation needs, the Council proposes reallocating project charge resources by increasing funding to Local Initiatives Support Corporation (\$250,000), the Community on the Frontline: Day Camp Program (\$150,000) and the Boris L. Henson Foundation, Joy Labs D7 (\$100,000). The proposed reallocation eliminates funding for the following organizations: Nu Momish (\$250,000), Diplomatic Perspective (\$150,000) and The Heights CDC: Town of District Heights (\$100,000).

Based on the official Consumer Price Index (CPI) for June 2025, the Homestead Property Tax Credit needs to be set at 103% for the taxable year beginning July 1, 2026, based on the limit in Section 812(d) of the County Charter which caps growth at 105%. The Homestead Property Tax Credit was created to limit taxable assessment increases on a property owner's principal residence.

This bill amends the principal use table to require special exception approval for certain residential developments in the Commercial, General and Office (CGO) Zone. The Zoning Ordinance currently permits five residential use types by right in the CGO Zone - townhouses, two-family dwellings, multifamily dwellings, live-work dwellings, and artists' residential studios. This bill would require developments of each of these use types to seek special exception approval to locate in the CGO Zone. Multifamily, two-family, and townhouse dwellings that are part of a group of adjoining lots or parcels in the CGO Zone that comprise less than 20 acres would be permitted by the approval of a special exception. If these dwellings comprise 20 acres or greater in size, the development would be permitted by approval of a Planned Development Zoning Map Amendment.

This bill seeks to address the oversaturation of drive-through fast food establishments in Prince George's County by changing the zones in which future restaurants may be placed. This legislation would prohibit fast-food drive-throughs in the remaining residential base zones in which they are now permitted by right (RMF-20, RMF-28) as well as the IE and TAC-Edge zones. Fast-food drive-throughs would continue to be permitted in CS and CGO zones, but such uses will be allowed only by special exception rather than by right. As a result, this legislation sets forth special exception standards which will be applied to all newly proposed fast-food drive-through developments and strikes the requirement to comply with drive-through service accessory use standards.
