**BACKGROUND INFORMATION/FISCAL IMPACT:**

Section 15-103 of the Land Use Article of the Annotated Code of Maryland requires that Prince George's County provide a reasonable geographic balance with respect to all Maryland-National Capital Park and Planning Commission appointments. This Resolution addresses the geographic distribution and balance of the membership of the Maryland-National Park and Planning Commission, and confirms William M. Doerner to serve as a member of the Maryland-National Capital Park and Planning Commission of the Prince George's County Planning Board. The appointment of William M. Doerner maintains the geographic distribution of the five (5) members of the Maryland-National Capital Park and Planning Commission from Prince George's County as reasonable as required by the law.
