**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will amend the Prince George’s County Fiscal Year (“FY”) 2022 Annual Action Plan for Housing and Community Development by adding new CDBG activities, eligible activities not originally funded or described in the FY 2022 Annual Action Plan.

Additionally, this Resolution will amend the FY 2022 Annual Action Plan by reprogramming and reallocating six hundred fifteen thousand, six hundred dollars (\$615,600) in Community Development Block Grant (“CDBG”) Program funds from the County FY 2019, FY 2020, and FY 2021 Annual Action Plans to support the new activities.

This Resolution requires at least one (1) public hearing because the proposed amendment to the FY 2022 Annual Action Plan would constitute a “substantial change” under the FY 2021-2025 County Citizen Participation Plan, as described in the County’s FY 2021-2025 Consolidated Plan.
