Order of Development Approvals

FOR the purpose of requiring that the order of approvals may not be waived nor is approval final until after the expiration of all appeals and reviews.

BY repealing and reenacting with amendments:

Section 27-270,

SECTION 1. BE IT ENACTED by the County Council of Prince
George's County, Maryland, sitting as the District Council for that
part of the Maryland-Washington Regional District in Prince George's
County, Maryland, that Section 27-270 of the Zoning Ordinance of
Prince George's County, Maryland, being also Subtitle 27 of the
Prince George's County Code, be and the same is hereby repealed and
reenacted with the following amendments:

- (a) When a Conceptual Site Plan or Detailed Site Plan is required unless otherwise provided for in this Subtitle, the following order of approvals shall be observed:
 - (1) Zoning;
 - (2) Conceptual Site Plan;
 - (3) Preliminary Plat of Subdivision;
 - (4) Detailed Site Plan;
- (5) Final Plat of Subdivision (a final plat of subdivision may be approved prior to a detailed site plan, if the technical staff determines that the site plan approval will not affect final plat approval);
 - (6) Grading, building, use and occupancy permits.
 - (b) This order of approvals may not be waived or varied from
