For the purpose of permitting vehicle sales or rental lot, including outdoor display of the vehicles in the I-3 Zone under certain circumstances.

BY repealing and reenacting with amendments:

Section 27-473(b),

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Section 27-473(b) of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, be and the same is hereby repealed and reenacted with the following amendments:

If not conducted in an existing office building, a Detailed Site Plan shall be approved in accordance with Part 3, Division 9, of this Subtitle.

## **Provided:**

- (A) The vehicle sales or rental lot is subordinate in area to, and is an expansion of, an existing permitted vehicle sales or rental use located on a contiguous adjacent lot in the I-1, I-2 or I-4 Zones; and
- (B) The two contiguous adjacent lots are owned by the same individual(s); and
- (C) The property on which the expansion will be located is adjacent to a public roadway; and
- (D) No structure may be erected except for paving, and with the exception of one structure not to exceed 6,000 square feet gross floor area which architecturally compatible with the surrounding neighborhood.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five (45) calendar days after its adoption.
