Committee Vote: Favorable as amended, 3-0, (In favor: Councilmembers Peters, Harrington and Knotts.)

This bill will amend the County's Classification Plan by adding Clerk Typist I and II and Administrative Aide I and II to the V Salary Schedule. These positions are part of the new Service Employees International Union Local 400PG Collective Bargaining Agreement. Salary Schedule V covers grades V-08 through V-17.

The Committee approved the following amendments:

- 1. On page 1, line 16, delete \$21,583 \$38,045 and insert \$20,544 \$36,212.
- 2. On page 1, line 18, delete \$23,797 \$41,946 and insert \$22,650 \$39,925.
- 3. On page 1, line 20, delete \$27,547 \$48,558 and insert \$26,220 \$46,218.
- 4. On page 2, line 1, delete \$30,371 \$53,534 and insert \$28,908 \$50,955.
- 5. On page 2, line 3, delete \$33,483 \$59,022 and insert \$31,870 \$56,178.
