RESOLUTION

1 A RESOLUTION concerning

2 The Enactment of a Certain Ordinance of the Town of Cheverly

3 For the purpose of approving the enactment of Ordinance No. 0-01-00 amending Chapter 18 of
4 the Code of the Town of Cheverly concerning abandoned vehicles.

5 WHEREAS, the Mayor and Town Council of the Town of Cheverly duly enacted
6 Ordinance No. 0-01-00 on April 13, 2000; and

7 WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code authorizes
8 municipalities within the Maryland-Washington Metropolitan District to enact ordinances
9 affecting parking on land either zoned for residential or commercial use or adjacent to residential
10 or commercial zones for the purpose of preserving, improving and protecting the general
11 character and design of lands within the corporate limits of the municipality, provided that such
12 ordinances impose stricter or additional limitations or restrictions than are otherwise imposed by
13 the County zoning regulations; and

14 WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that
15 such ordinance shall not be effective until approved by the County Council of Prince George's
16 County, sitting as the District Council; and

17 WHEREAS, the Town of Cheverly, pursuant to Section 8-112.1 of Article 28 of the
18 Maryland Annotated Code, has delivered a certified copy of the Ordinance to the District
19 Council; and

1 WHEREAS, the District Council has determined that the Ordinance imposes additional
2 conditions upon residential parking than those currently imposed by Subtitle 27 of the Prince
3 George's County Code (the "Zoning Ordinance").

4 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
5 County, Maryland, sitting as the District Council for that part of the Maryland-Washington
6 Regional District in Prince George's County, Maryland, that Ordinance No. 0-01-00 adopted by
7 the Town of Cheverly, as represented in Attachment A to this Resolution, be and is hereby
8 APPROVED.
