WHEREAS	s, on May 11, 2010, the County Council adopted CR-26-2010, thereby
approving the Ho	ousing and Community Development Consolidated Plan: FY 2011 – 2015; and
WHEREAS	s, incorporated by reference in the adoption of the FY $2011 - 2015$ Consolidated
Plan is a public p	participation process as required by Subtitle 15A of the Prince George's County
Code; and	
WHEREAS	s, within the "Managing the Process" section of the Approved FY 2011-2015
Consolidated Pla	n, a program of public participation is incorporated, thereby setting forth certain
procedural requir	rements as to notice and public hearing for public comments on the proposed
Consolidated Pla	n; and
WHEREAS	s, the approved public participation process requires that the County hold at least
two public hearir	ngs or provide certain notices on the Consolidated Plan, Annual Action Plan and
any substantial a	mendment to those plans; and
WHEREAS	, pursuant to the public participation program adopted in CR-26-2010, notice of

the time, date, and subject of the public hearings on the Consolidated Plan, Annual Action Plan

and any substantial amendment to those plans must be published least fourteen (14) days prior to each public hearing on the Consolidated Plan, Annual Action Plan and any substantial amendment to those plans; and

WHEREAS, CR-90-2013, an substantial amendment to Annual Action Plan for Housing and Community Development: FY 2013 to approve the reprogramming certain funds in the HOME Investment Partnership ("HOME") funds to the "My Home" program, was introduced on behalf of the County Executive on September 10, 2013 and scheduled for a public hearing; and

WHEREAS, notice was provided by the County in accordance with the prescription of the public participation program concerning a public hearing on the to be held on October 1, 2013; and

WHEREAS, after notice of the proposed public hearing was published, the County was advised by the United States Department of Housing and Urban Development that the funds proposed for reprogramming by amendment to the Annual Action Plan, as set forth in CR-90-2013, would lapse after September 30; and

WHEREAS, in furtherance of achieving the important public interest of reprogramming approximately \$1,079,233 in HOME Investment Partnership to the "My Home" Program, there is a need to temporarily suspend the 14-day public notice requirement of the Approved Housing and Community Development Consolidated Plan FY 2011 – FY 2015 by one day for the limited purpose of allowing the public hearing to be held and final action considered as to CR-90-2013 on September 30, 2013; and

WHEREAS, the County Executive and the Department of Housing and Community
Development (DHCD) have requested suspension of the 14-day public notice requirement to
meet the United States Department of Housing and Community Development deadline; and

WHEREAS, pursuant to Section 1017(c) of the County Charter, a Resolution has the force and effect of law but of a temporary or administrative character.

1	NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's	
2	County, Maryland, that the 14-day public notice requirement of the Approved Housing and	
3	Community Development Consolidated Plan FY 2011 – FY 2015 be and the same is hereby

5	held and final action considered as to CR-90-2013 on September 30, 2013.
