

## A RESOLUTION concerning

For the purpose of temporarily amending a provision of the approved Housing and Community Development – Consolidated Plan FY 2011-2015 public participation program in order to amend the Annual Action Plan for Housing and Community Development: FY 2013 and approve the reprogramming certain funds in the HOME Investment Partnership (“HOME”) funds to the “My Home” program.

WHEREAS, incorporated by reference in the adoption of the FY 2011 – 2015 Consolidated Plan is a public participation process as required by Subtitle 15A of the Prince George’s County Code; and

WHEREAS, the approved public participation process requires that the County hold at least two public hearings or provide certain notices on the Consolidated Plan, Annual Action Plan and any substantial amendment to those plans; and

1 and any substantial amendment to those plans must be published least fourteen (14) days prior to  
2 each public hearing on the Consolidated Plan, Annual Action Plan and any substantial  
3 amendment to those plans; and

4 WHEREAS, CR-90-2013, an substantial amendment to Annual Action Plan for Housing  
5 and Community Development: FY 2013 to approve the reprogramming certain funds in the  
6 HOME Investment Partnership (“HOME”) funds to the “My Home” program, was introduced on  
7 behalf of the County Executive on September 10, 2013 and scheduled for a public hearing; and

8 WHEREAS, notice was provided by the County in accordance with the prescription of the  
9 public participation program concerning a public hearing on the to be held on October 1, 2013;  
10 and

11 WHEREAS, after notice of the proposed public hearing was published, the County was  
12 advised by the United States Department of Housing and Urban Development that the funds  
13 proposed for reprogramming by amendment to the Annual Action Plan, as set forth in CR-90-  
14 2013, would lapse after September 30; and

15 WHEREAS, in furtherance of achieving the important public interest of reprogramming  
16 approximately \$1,079,233 in HOME Investment Partnership to the “My Home” Program, there  
17 is a need to temporarily suspend the 14-day public notice requirement of the Approved Housing  
18 and Community Development Consolidated Plan FY 2011 – FY 2015 by one day for the limited  
19 purpose of allowing the public hearing to be held and final action considered as to CR-90-2013  
20 on September 30, 2013; and

21 WHEREAS, the County Executive and the Department of Housing and Community  
22 Development (DHCD) have requested suspension of the 14-day public notice requirement to  
23 meet the United States Department of Housing and Community Development deadline; and

24 WHEREAS, pursuant to Section 1017(c) of the County Charter, a Resolution has the force  
25 and effect of law but of a temporary or administrative character.

1        NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
2        County, Maryland, that the 14-day public notice requirement of the Approved Housing and  
3        Community Development Consolidated Plan FY 2011 – FY 2015 be and the same is hereby  
4        temporarily suspended by one day for the limited purpose of allowing the public hearing to be  
5        held and final action considered as to CR-90-2013 on September 30, 2013.
