Introduction of Resolutions

CR-3-2004 – A RESOLUTION CONCERNING APPROVAL OF A CERTAIN

REFUNDING PLAN OF THE WASHINGTON SUBURBAN SANITARY COMMISSION

FOR THE ISSUANCE OF REFUNDING BONDS for the purpose of approving the Refunding Plan of the Washington Suburban Sanitary Commission for the refunding of certain bonds of Washington Suburban Sanitary District through the issuance of General Construction Refunding Bonds, Water Supply Refunding Bonds and Sewerage Disposal Refunding Bonds of Washington Suburban Sanitary District. - INTRODUCED

Council Resolution 3 approves the request by the Washington Suburban Sanitary Commission for the refunding of certain bonds through the issuance of General Construction, Water Supply and Sewage Disposal Refunding Bonds in the approximate amount of \$270,745,000 on February 3, 2004. Council Resolution 3 was proposed by the Chairman, by request of the Washington Suburban Sanitary Commission, and referred to the Transportation, Housing and the Environment Committee. Council Resolution 3 was introduced by Chairman Knotts and Council Member Shapiro.

<u>CR-4-2004 – A RESOLUTION CONCERNING PRIVATE SCHOOLS IN THE R-R ZONE</u> for the purpose of temporarily suspending certain requirements for the operation of a private school in the R-R Zone under certain circumstances. - *INTRODUCED*

Council Resolution 4, which allows for the issuance of a Use and Occupancy permit, on a temporary basis, for a private school to be located in an existing structure without first obtaining a special exception under certain circumstances, was introduced by Council Members Dernoga, Knotts, Dean, Exum, Peters, Shapiro and Harrington and referred to the Committee of the Whole. Chairman Knotts announced that the public hearing for Council Resolution 4 would be held on January 20, 2004 at 1:30 p.m.
