**BILL**

1 AN ACT concerning

2 Fiscal Year 2008-2009 Current Expense Budget

3 For the purpose of amending certain revenue estimates and certain appropriations in the Annual  
 4 Budget and Appropriations Ordinance for Fiscal Year 2008-2009

5 BY amending:

6 Chapter 8, The Laws of Prince George's County, Maryland of 2008

7 WHEREAS, the Annual Budget and Appropriation Ordinance of Prince George's County  
 8 for Fiscal Year 2008 – 2009 was adopted by CB-28-2008; and

9 WHEREAS, Section 817 of the Prince George's County Charter provides that if the  
 10 County Executive shall ascertain that the available revenue for the year may be less than the total  
 11 appropriations, he shall reconsider the appropriations for all agencies, and may revise them so as  
 12 to forestall expenditures in excess of the income and fund balances; and

13 WHEREAS, there has been a decline in anticipated revenues necessitating a reduction in  
 14 appropriations and expenditures; now, therefore,

15 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 16 Maryland, that Chapter 8, The Laws of Prince George's County, Maryland of 2008, being the  
 17 Annual Budget and Appropriations Ordinance for FY 2008-2009 be and the same is hereby  
 18 amended as to revenues and appropriations as set forth in Exhibits 1 and 2 attached hereto and  
 19 made a part hereof.

20 SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby  
 21 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,

1 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of  
2 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining  
3 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this  
4 Act, since the same would have been enacted without the incorporation in this Act of any such  
5 invalid or unconstitutional word, phrase, clause, sentence, subparagraph, subsection, or section.

6 SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
7 calendar days after it becomes law.
