**PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT** Date: 10/22/03

Committee Vote: Favorable, 4-0, (In favor: Councilmembers Exum, Bland, Knotts and Peters.)

This resolution will amend the Salary Plan in Salary Schedule Q for the civilian employees in the Prince George's Correctional Officers Association, Inc., (PGCOA), Civilian Unit, and reflects modifications of the new two year agreement (FY2004 – FY2005).

The Legislative Officer and the County Attorney have reviewed this resolution and find it to be in proper legislative form with no legal impediment to its adopted.

The highlights of the Salary Plan and fiscal impact are included in CB-80-2003.

**BACKGROUND INFORMATION/FISCAL IMPACT**

This resolution is companion legislation to the bill to approve the collective bargaining agreement for a unit of civilian employees in the department of Corrections, between Prince George's County, Maryland and PGCOA.
