**RESOLUTION**

1 A RESOLUTION concerning  
2 Maryland-National Capital Park and Planning Commission  
3 For the purpose of approving certain transfers of appropriations within the Approved FY 2023–24  
4 Recreational Fund of the Approved Fiscal Year 2023–24 Maryland-National Capital Park and  
5 Planning Commission.

6 WHEREAS, the Annual Budget and Appropriation Ordinance for the Prince George’s  
7 County portion of the Maryland-National Capital Park and Planning Commission for Fiscal Year  
8 2023–24 was adopted on May 25, 2023 by approval of CB-62-2023; and

9 WHEREAS, under the provisions of Title 18, Land Use Article, Annotated Code of  
10 Maryland, the Commission budget may be amended by resolution of the respective County  
11 Councils on their initiative after public hearing upon reasonable notice to the public; and

12 WHEREAS, there is a need to fund the following programs: Guns Down Friday, Community  
13 On the Frontline, Judge Me Now, Impact One, Shabach Ministries, Inc., and The Heights  
14 Community Development Corporation; and

15 WHEREAS, in order to identify additional funding for those named programs, there is a need  
16 to decrease funding from the approved Recreation Fund for District Heights Youth Programing,  
17 District Heights Senior Programming, and Make Smart Cool; and

18 WHEREAS, Section 18-108 of the Land Use Article provides a process by which approved  
19 Commission budgets may be amended by resolution of the County Council after public hearing  
20 upon reasonable notice to the public.

21 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County,  
22 Maryland, that the following adjustments to the approved Fiscal Year 2023–24 Maryland-National  
23 Capital Park and Planning Commission Operating Budget Recreation Fund, as approved in CB-

1 062-2023, are hereby made for the purposes set forth above:
