It is my pleasure to submit to you and the County Council the appointment of Mr. Michael D. Johnson as Director of the Department of Public Works and Transportation (DPW&T) for Prince George's County. He has served as Acting Director since June 6, 2022. Mr. Johnson possesses the knowledge, skills, and experience necessary for operation of the Department of Public Works and Transportation (DPW&T).

Mr. Michael D. Johnson, P.E. is a high performing executive with more than three (3) decades of public works and engineering experience. He was most recently Director of Public Works for the City of Annapolis where he directed unionized and non-unionized staff and developed and implemented a \$15 million annual operating budget and a \$25 million infrastructure and stormwater capital improvement program. His commitment to human capital included a career path program for line and professional staff that provided an organized way of developing staff skill competencies with concomitant compensation. He previously served as Director of Public Works and City Engineer for the City of Gaithersburg and was Acting Executive Director of Water Utility for the City of East Orange. His private industry experience included Lichtenstein Engineers, LLP and Vollmer Associates, LLP.

Mr. Johnson received his Bachelor of Engineering degree in Civil Engineering from the City College of New York and a Master of Science in Operations Research degree from Columbia University. He was credentialed as a Certified Municipal Engineer by the State of New Jersey.
