RESOLUTION

1 A RESOLUTION concerning
2 The Maryland-National Capital Park and Planning Commission – Appointment and Geographic
3 Balance

4 For the purpose of approving the appointment of Manuel R. Geraldo as a commissioner of the
5 Prince George’s County Planning Board of the Maryland-National Capital Park and Planning
6 Commission, and providing a description and appropriate explanation of the resulting geographic
7 balance in accordance with requirements of State law.

8 WHEREAS, Section 15-103(b) of the Land Use Article of the Annotated Code of Maryland
9 sets forth the procedures for appointment of commissioners to the Maryland-National Capital
10 Park and Planning Commission in Prince George’s County; and

11 WHEREAS, Section 15-103(b) requires that the County Council hold a public hearing on
12 an appointment to the Commission not later than twenty (20) days, and may approve or
13 disapprove the appointment within thirty (30) days after the County Executive submits the name
14 of the appointee to the County Council; and

15 WHEREAS, Section 15-103(b)(4) requires that the resolution for each appointment
16 describe the resulting geographic distribution and provide appropriate explanations; and

17 WHEREAS, the County Executive has duly nominated Manuel R. Geraldo, a resident of
18 Fort Washington, to serve as a member of the Maryland-National Capital Park and Planning
19 Commission of the Prince George’s County Planning Board; and

20 WHEREAS, a public hearing on the appointment of Manuel R. Geraldo to the Commission
21 has been held before the County Council; and

1 WHEREAS, the remaining four (4) members of the Commission from Prince George's
2 County are residents of Bowie, Temple Hills, Mitchellville and University Park, respectively.

3 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
4 County, Maryland, sitting as the District Council for that part of the Maryland-Washington
5 Regional District in Prince George's County, Maryland, that, as a result of appointment of
6 Manuel R. Geraldo as commissioner of the Maryland-National Capital Park and Planning
7 Commission, there continues to be a reasonable geographic distribution with respect to the places
8 of residence of the members of the Commission from Prince George's County.

9 BE IT FURTHER RESOLVED that appointment of Manuel R. Geraldo as a commissioner
10 of the Maryland-National Capital Park and Planning Commission for a term expiring June 15,
11 2019, be and the same is hereby approved.
