**RESOLUTION**

1 A RESOLUTION concerning

2 Department of Permitting, Inspections and Enforcement

3 For the purpose of increasing all fees maintained by the Department of Permitting, Inspections  
4 and Enforcement, with such increase to be approved by the County Council after notice and  
5 public hearing.

6 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the  
7 Department of Permitting, Inspections and Enforcement (“DPIE”) shall establish and maintain a  
8 table of fees for all types of permits and such table shall be published on the DPIE website; and

9 WHEREAS, Attachment A is the current Table of Fees established, maintained and  
10 published by DPIE, attached hereto and made a part of the record hereof; and

11 WHEREAS, pursuant to Section 2-253.63 of the Prince George’s County Code, the  
12 Director of DPIE or County Council shall have the authority to change the fees as deemed  
13 necessary; and

14 WHEREAS, prior to changing the fees, DPIE must hold a public information session to  
15 allow for public comment, must submit the fee changes to the County Executive for approval,  
16 and then must submit the fee changes to County Council by Resolution for approval after notice  
17 and a public hearing; and

18 WHEREAS, Attachment B is the proposed Table of Fees with a twenty percent (20%)  
19 increase of all fees, along with a ten percent (10%) Technology fee, attached hereto and made a  
20 part of the record hereof; and

21 WHEREAS, the County Executive reviewed such changes and approved the increase as  
22 appropriate and necessary.
