

DJS INTAKE



Intake Decision Tool


The tool DJS utilizes to assess risk and needs of youth when charged with a delinquent act. The tool helps DJS intake staff determine if it is in the best interest of the youth and public safety to resolve, pre-court, or forward a referral to the states attorney.

By law, DJS is required to forward all crimes of violence directly to the State's Attorney.

DETENTION REQUESTS



DETENTION RISK ASSESSMENT

An objective and validated tool that assesses the degree to which youth pose a public safety and/or flight risk. Risk score calculations are used to create a recommendation for release, community-based alternative to detention (ATD), or secure detention. All ATD and secure detention decisions made by DJS are reviewed and continued or modified by the Juvenile Court on the next business day.

ALTERNATIVES TO DETENTION (ATD)

in Prince George's County

- Community Detention
- Community Detention with Electronic Monitoring
- Evening Reporting Center


DJS enacted "Safe Friday" contacts to further enhance supervision of ATD youth leading into and during weekends (Sep 2023)

DJS CASE FORWARDING DECISIONS



PRINCE GEORGE'S DJS INTAKE REFERS CASES TO THE JUVENILE COURT AT A SIGNIFICANTLY HIGHER RATE THAN THE REST OF THE STATE (2x more by comparison)



PROBATION AND AFTERCARE



PROBATION TERMS

MISDEMEANORS



6 months, not to exceed 1 year

NON-VIOLENT FELONIES



1 year, not to exceed 3 years

CRIME OF VIOLENCE FELONIES



No Term Limit



Only the Juvenile Court has the authority to release a youth from probation



Treatment Program (DJS Operated)



DJS COMMITTED PROGRAMS





85% of youth released from committed programs have no new sustained juvenile or adult offense within one year

EDUCATION

JUVENILE SERVICES EDUCATION PROGRAM (JSEP)



SB 497, Chapter 145 passed and signed into law 2021

JSEP established as the **25th school board** in Maryland and housed in DJS as an independent unit

Academic Services:

- 6.5 hours of academic services, Monday Friday
- DJS began afterschool clubs in facilities in 2023 (art, movies, music, civics, etc.)
- Re-enrollment planning and execution in coordination with DJS Community Services staff
- Dual enrollment for youth held temporarily in DJS detention facilities to ensure continuity of academic programming
