#### RESOLUTION

#### A RESOLUTION concerning

The Washington Suburban Sanitary Commission Fiscal Years
1996-2001 Capital Improvements Program
for Prince George's County for Water and Sewerage

For the purpose of amending the WSSC Fiscal Years 1996-2001 Capital Improvement Program for Water and Sewerage.

WHEREAS, Article 29, Title 7 of the Annotated Code of Maryland requires the Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit a Capital Improvement Program and any amendments thereto to the County Executive and County Council of Prince George's County; and

WHEREAS, this WSSC Capital Improvement Program is part of the Adopted County Comprehensive Ten Year Water and Sewerage Plan and contains projects to support water supply and sewerage system development as proposed in the plan; and

WHEREAS, the County Council adopted the "WSSC Capital Improvements Program for Fiscal Years 1996-2001 and Capital Budget for Fiscal Year 1996" on May 31, 1995 with the adoption of CR-24-1995; and

WHEREAS, the WSSC has transmitted its request for amendment to Fiscal Year 1996-2001 Capital Improvement Program and supplement to the Fiscal Year 1996 Capital Budget on September 27, 1995; and

WHEREAS, Article 29, Title 7 of the Annotated Code of Maryland further provides that after notice to the public and a public hearing, the County Council shall approve, disapprove

or modify the WSSC Capital Improvement Program; and

WHEREAS, all other requirements of Article 29, Title 7 of the Annotated Code of Maryland that concern final action by the Council on the WSSC Capital Improvement Program for Water Sewerage and for Stormwater management have been met;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the "Capital Improvements Program Fiscal Years 1996-2001 Capital Budget Fiscal Year 1996" for Water and Sewerage as approved in CR-24-1995, is hereby amended by the attached Appendix 1.
