## PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT Date: 7/3/96

Committee Vote: Favorable, 4-0-1 (In favor: Council Members Estepp, Del Giudice, Maloney and Scott. Abstained: Bailey).

This bill will amend the Section of the County Code which relates to swimming pools. The amendments were prepared with industry representatives to develop regulations that are more user friendly and less restrictive without compromising public health concerns.

The swimming pool fees are removed from the text of the County Code and will be recommended by the County Executive and adopted by Resolution.

There will be no fiscal impact on the County as a result of enacting CB-62-1996.
