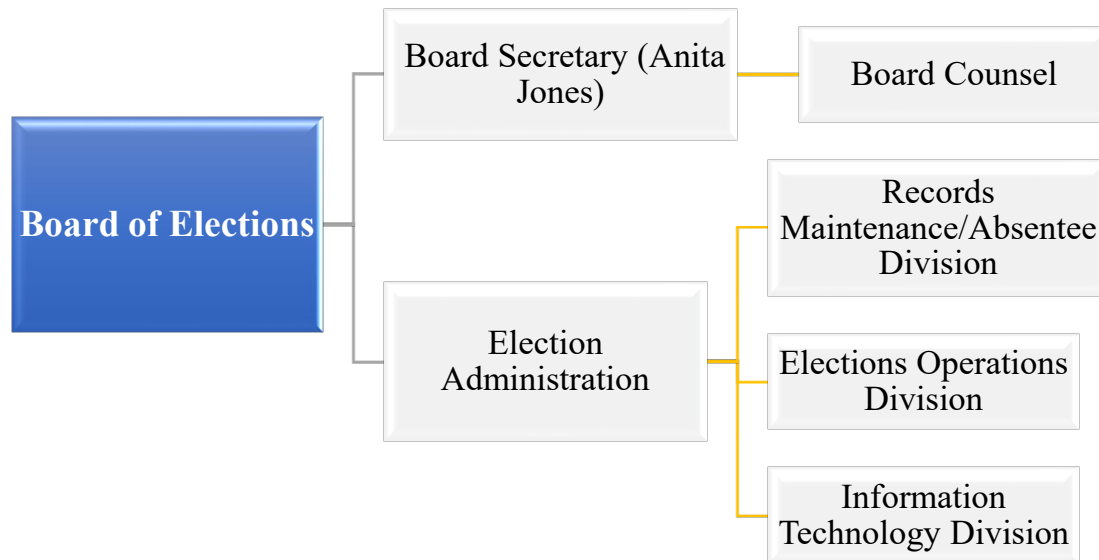

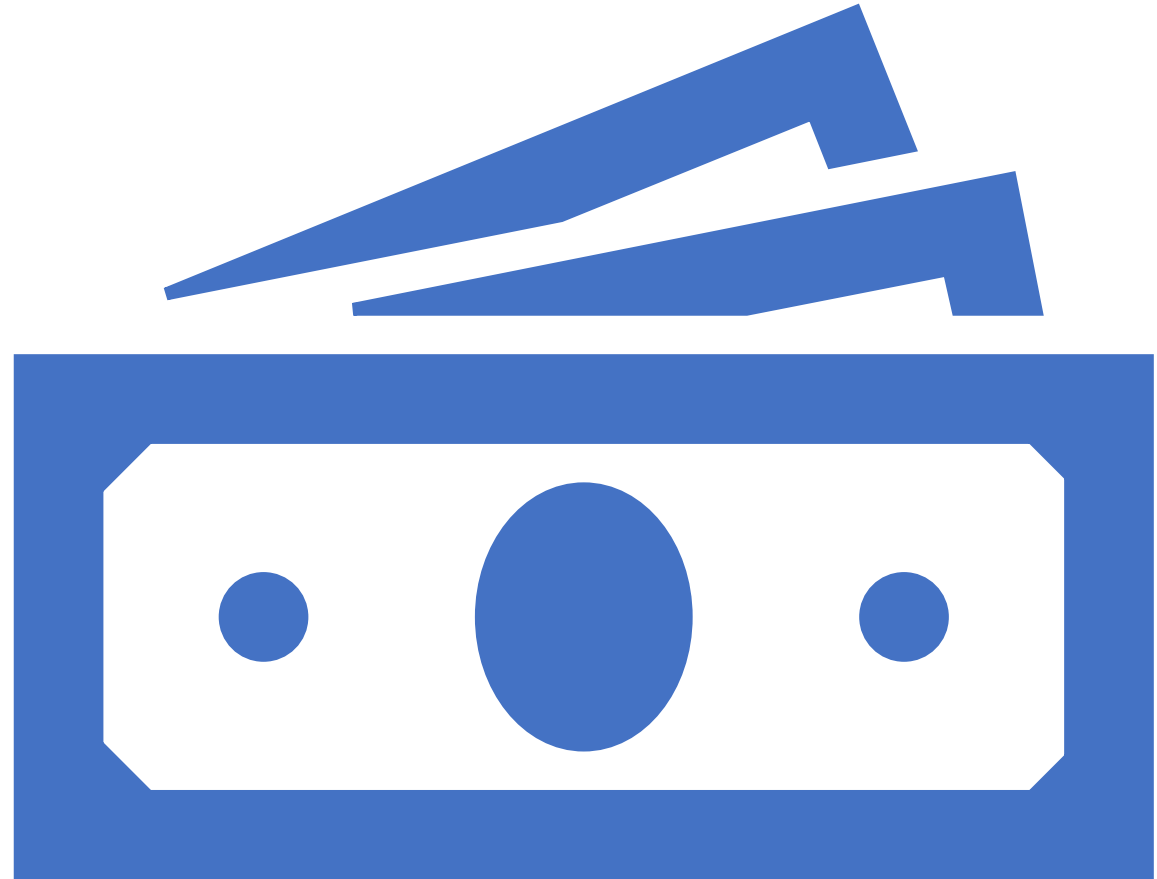
Prepare for and conduct the 2026 Gubernatorial Primary Election.

Continue efforts to reduce the number of duplicate voters registered in various states utilizing the Electronic Registration Information Center (ERIC).

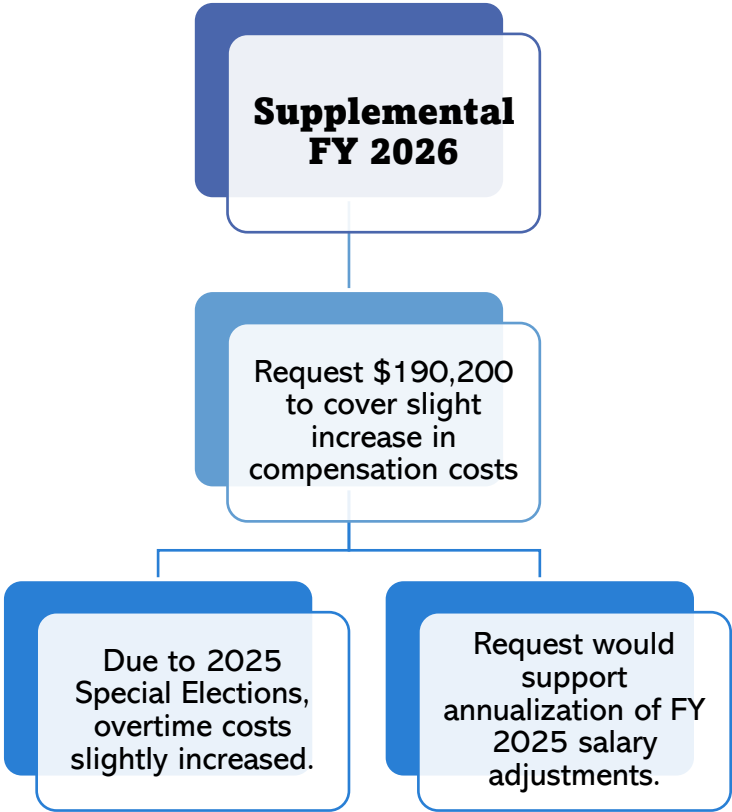
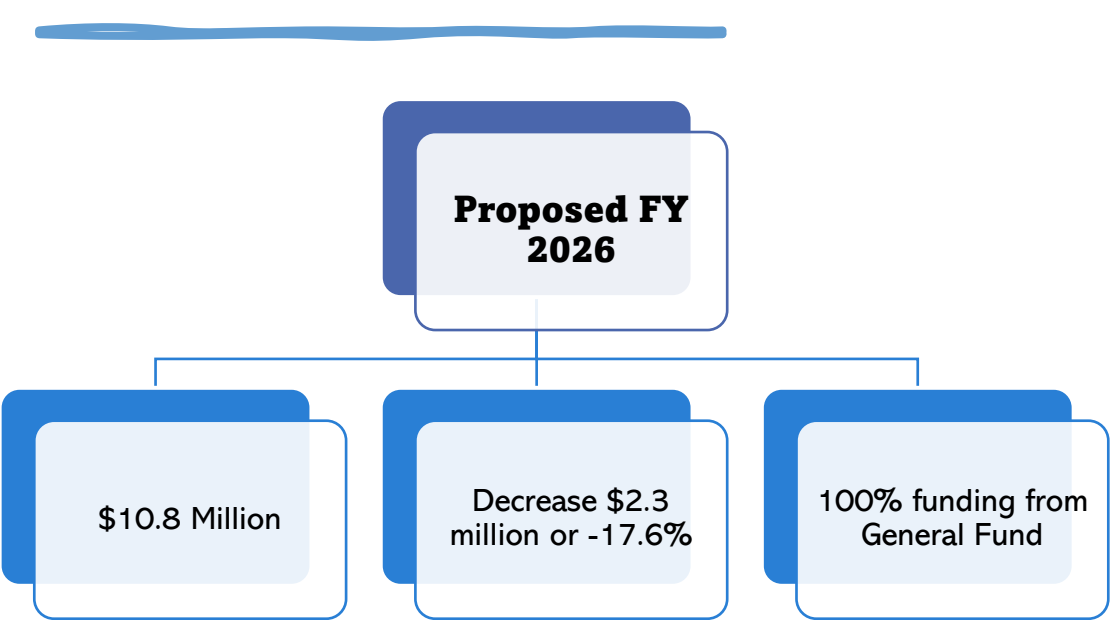

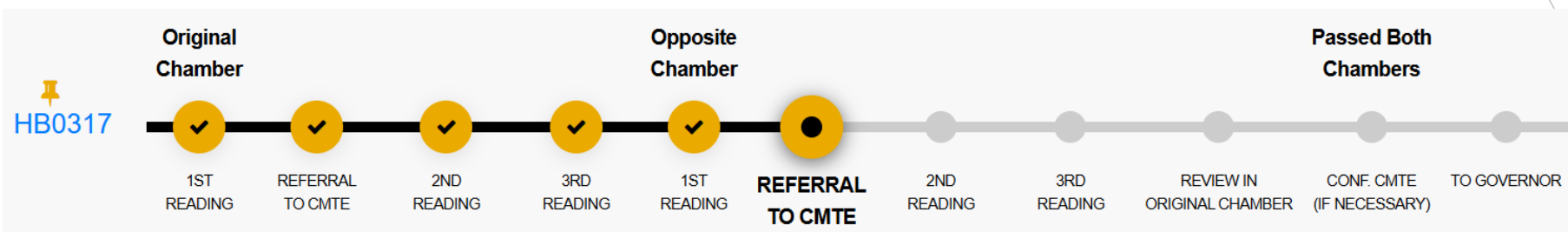
Operational & Fiscal Impact Cont.

State Legislation

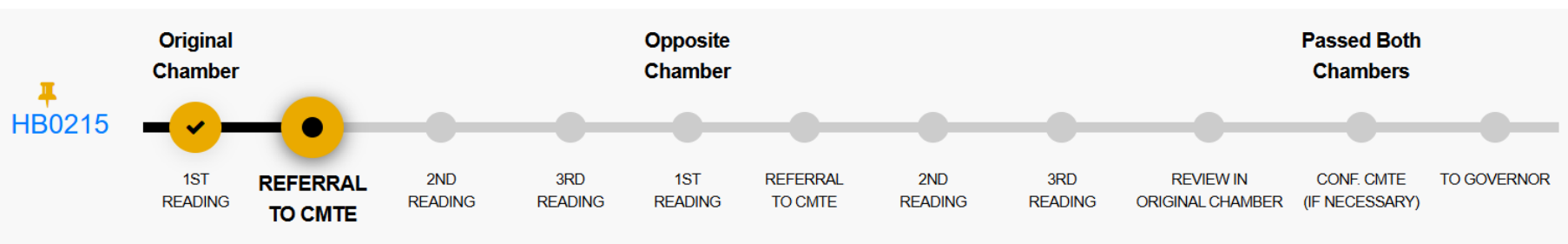
- **HB0317 – Curbside Voting – Pilot Program**
 - Significant fiscal impact
 - Additional staff, election judges, and potentially new polling places needed.
 - Possibly need outdoor tents, additional voting equipment, lighting, generators, etc.
- **HB0215 – Ranked-Choice Voting – Presidential Nomination**
 - Increase in expenditures to pay canvassers and tabulate results.
- **HB1200 – Election Judges – Minimum Compensation (Enacted/Approved during 2023 Session)**
 - Cost the Board \$349,400/per fiscal year. Incorporated into budget approved.
