AN ACT concerning

The Classification Plan for Prince George's County

FOR the purpose of adding new classes of work, abolishing existing classes of work, and changing the titles and/or grades for certain classes of work.

WHEREAS, the County Executive, pursuant to Section 903 of the Prince George's County Charter and Section 16-125(a) of Subtitle 16 of the Prince George's County Code, has, in order to provide better governmental services, recommended to the County Council amendments to the Classification Plan for Prince George's County with respect to certain classes of work described within Section 1 of this bill, recognized by the County to provide better governmental services; now, therefore,

SECTION 1. BE IT ENACTED by the County Council of Prince George

's County, Maryland, that the Classification Plan for Prince George's County be and the same is hereby amended as follows:
