**BACKGROUND INFORMATION/FISCAL IMPACT:**

Prince George’s County, Maryland and the International Association of Fire Fighters, Local 1619, AFL-CIO (Fire Fighters, Paramedics and Fire Fighter/Medics) have completed labor negotiations on a one year labor agreement covering Fiscal Year 2016. This bill is to adopt and approve the referenced collective bargaining agreement in accordance with Section 16-233(f) of the Personnel Law.
