#### A RESOLUTION concerning

A Supplementary Appropriation of Federal, State and Other Funds

For the purpose of providing additional funding from grants in the amount of \$3,738,616 to

Board of License Commissioners, Circuit Court, Police Department, Fire Department,

Department of Environmental Resources, Department of Family Services, Health Department,

Department of Housing and Community Development, Department of Social Services and to

Non-Departmental.

WHEREAS, CB-22-1996, as amended, adopted and enacted the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 1996-1997, which set forth the amount of grant funds to be appropriated; and

WHEREAS, under the provisions of Section 819 of the Charter of Prince George's County, Maryland, the Council, upon recommendation of the County Executive, may, by resolution, make additional or supplementary appropriations from Federal, State, or private grants which were not included in the budget for Fiscal Year 1996-1997; and

WHEREAS, additional grant revenues have been received; and

WHEREAS, the director of Finance has certified in writing that such funds are available for such appropriation; and

WHEREAS, the County Executive has duly recommended that the supplementary appropriations be made.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1996-1997 Approved Current Expense Budget,

#### **ATTACHMENT**

#### **EXPLANATION FOR ADDITIONAL GRANT AWARDS**

#### **Board of License Commissioners**

ALCOHOL AWARENESS SEMINAR (\$10,000) - The Board of License Commissioners is sponsoring a seminar on alcohol awareness issues to licensees to increase awareness of consequences of negligent retailing including sales to minors. This appropriation authorizes collection of registrations which will support the seminar costs.

### Circuit Court

FAMILY COURT INITIATIVE (\$140,000) - This grant provides for continuation of the Initiative which supports additional resources to enhance services to citizens, particularly prose litigants, who are seeking assistance from the courts in the area of family law.

#### Police Department

METRO ALIEN FRAUD TASK FORCE (FY96) (\$4,500) - This grant, which was awarded late in FY96, supports overtime costs of officers assigned to participate in activities of the task force along with the U.S. Secret Service.

REPEAT OFFENDERS UNIT (\$5,610) - The Governor's Office of Crime Control and Prevention has awarded funds for purchase of a computer system for the Repeat Offender Unit.

VICTIM OUTREACH PROGRAM (\$25,000) - This grant from the Governor's Office of Crime Control and Prevention will fund staff costs of services offered to victims and witnesses of crime.

SEROLOGY LABORATORY GRANT (\$156,030) - This grant supports costs for in-house testing of evidence for law enforcement agencies in the County.

DRUG ENFORCEMENT ADMINISTRATION- OPERATION C.L.E.A.N. (\$40,000) - This program, Citizens and Law Enforcement Against Narcotics, funds costs related to narcotics enforcement including overtime for officers.

U.S. CUSTOMS/HIDTA (\$22,000) - This funding supports an initiative to investigate money laundering by drug dealers, organizations and gangs in the region.

ALCOHOL/DRUG HIGHWAY SAFETY GRANT (\$25,000) - Additional grant funds are available to expand this program which includes support to municipal police organizations

and community groups to promote highway safety and enforce motor vehicle laws. Fire Department

CHURCH ARSON PREVENTION GRANT (\$4,208) - U.S. Department of Justice funds will support efforts to prevent attacks on houses of worship.

Department of Environmental Resources

MARYLAND SUSTAINABLE COMMUNITIES PROGRAM (\$50,000) - The Maryland Energy Administration grant will promote energy efficiency through demonstrations and evaluation of energy conserving technologies.

# **Department of Family Services**

IRS TAX PREPARATION GRANT (\$708); COMMUNITY HOME CARE HOME VISITATION PROGRAM (\$220) - A small amount of additional Federal funds have been awarded for these programs.

BENEFITS SCREENING PILOT (\$18,750) - Additional State funds will extend the grant through the end of FY97.

MENTAL HEALTH AUTHORITY CORE SERVICE AGENCY (\$81,060) - Additional Federal mental health block grant funds are anticipated as well as additional State funds for medical assistance matching payments to service providers.

MENTAL HEALTH AUTHORITY/TRANSITIONAL LIVING GRANT (\$300,000) - This amount represents approximately one third of the award amount for a new multi-year, multi-agency Transitional Housing grant award from the U.S. Department of Housing and Urban Development.

### **Health Department**

COG METROPOLITAN AREA TREATMENT ENHANCEMENT SYSTEM (\$96,000) The Council of Governments has awarded funds to provide supportive housing services for substance-abusing women and their families. The program will be integrated into the Transitional Housing programs operated by the Department of Social Services.

COLPOSCOPY (\$9,383); IMMUNIZATION ACTION PROJECT (\$58,606); TB COOPERATIVE AGREEMENT (\$29,943); HEPATITIS B PREVENTION (\$140,000) - Grant awards for these grants exceed the amounts included in the FY97 Approved Budget.

### Department of Housing and Community Development

COMMUNITY DEVELOPMENT BLOCK GRANT (\$179,017) - Federal funds awarded for the Block Grant exceed the amount included in the FY97 Approved Budget. Also, program income is being added to the revenues of the overall grant budget to support additional program year expenditures.

## **Department of Social Services**

SERVICE-LINKED HOUSING PROGRAMS (\$17,581) - The award for this program, which supports subgrants to two community providers of services to prevent homelessness, exceeds the amount of funding included in the Approved Budget.

TRANSITIONAL HOUSING IV (\$400,000) - An application - submitted some months ago to the U.S. Department of Housing and Urban Development - for a new three year grant program to help homeless individuals and families move to self-sufficiency and permanent housing has received funding awards. The application requested funding for County agency efforts as well as those of private community-based providers. However, details of the award are not yet available. Pending further clarification, the amount of appropriation included in this legislation represents approximately one-third of the amount awarded to the Department of Social Services.

MARYLAND JOBS INITIATIVE (\$1,800,000) - This funding represents transfer from the Maryland Department of Human Resources funds to support the "welfare to work" initiative in this County by providing resources to support job assessments, training and job placements.

#### Non-Departmental

TRANSIT STATION AREA DEVELOPMENT INCENTIVE GRANT (\$125,000) - The Maryland Department of Transportation has awarded funds to finance a portion of the Queens Chapel Road Shopping Center Revitalization which consists of roadway landscaping improvements in the area of the West Hyattsville Transit District.
