**BILL**

1 AN ACT concerning

2 Maryland-National Capital Park and Planning Commission

3 For the purpose of amending the provisions of Chapter 29, Laws of Prince George's County,  
 4 Maryland 1998 concerning the approval of the Prince George's County portion of the Maryland-  
 5 National Capital Park and Planning Commission budget to restrict the hours of operations of  
 6 certain recreational facilities and activities funded in the adopted budget.

7 BY adding:

8 Section 12,

9 Chapter 29,

10 Laws of Prince George's County, Maryland, 1998.

11 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 12 Maryland that Section 12 of Chapter 29 (CB-53-1998) of the Laws of Prince George's County,  
 13 Maryland, be and the same is hereby added to read as follows:

14 SECTION 12. ENTERPRISE FUND FACILITY OPERATIONS. BE IT

15 FURTHER ENACTED that each event for which admission is charged at the Show  
 16 Place Arena or the Prince George's Equestrian Center shall be scheduled to begin no  
 17 later than 9:00 p.m. and that each such event shall be scheduled to conclude no later  
 18 than 12:00 a.m. unless additional hours for a particular event have been approved by  
 19 the Director of Parks and Recreation. These hours of operation shall not include  
 20 events that are directly sponsored by the Maryland-National Capital Park and  
 21 Planning Commission or by the Prince George's County Government.

1       SECTION 2. BE IT FURTHER ENACTED that SECTION 12. SEVERABILITY shall be  
2       renumbered to be SECTION 13.

3       SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
4       calendar days from the date it becomes law.
