This Resolution will amend the Prince George's County Fiscal Year ("FY") 2016 Annual Action Plan for Housing and Community Development by adding the Arnold Gardens project, an eligible activity not originally funded or described in the FY 2016 Annual Action Plan.

Additionally, this Resolution will amend the FY 2016 Annual Action Plan by reprogramming and reallocating nine hundred seventy-five thousand dollars (\$975,000) in HOME Investment Partnerships (HOME) Program funds from the FY 2014 and FY 2016 Annual Action Plans to support the Arnold Gardens project.

This Resolution requires at least one public hearing because each of the proposed amendments to the FY 2016 Annual Action Plan would constitute a “substantial change” under the FY 2016-2020 County Citizen Participation Plan.
