1 A RESOLUTION concerning

2 Supplementary Appropriation of Federal, State and Other Funds

3 For the purpose of appropriating funding from grants in the amount of \$176,626,110 for Non-
4 Departmental.

5 WHEREAS, CB-024-2020, as amended, adopted and enacted the Annual Budget and
6 Appropriation Ordinance of Prince George’s County for Fiscal Year 2021, which set forth the
7 amount of grant funds to be appropriated; and

8 WHEREAS, pursuant to Section 815 of the Charter of Prince George’s County, Maryland,
9 the County Council upon recommendation of the County Executive, may, by resolution, make
10 additional or supplementary appropriations from Federal, State or private grants which were not
11 included in the budget for the current fiscal year; and

12 WHEREAS, accountability measures regarding expenditure of the additional grant awards
13 are necessary; and

14 WHEREAS, additional grant awards have been received; and

15 WHEREAS, the County Executive has duly recommended that supplementary
16 appropriations be made.

17 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
18 County, Maryland, that Fiscal Year 2021 Approved Current Expense Budget, Federal Programs

 8 are included in a transparent manner in County budget documents.

9 BE IT FURTHER RESOLVED that this Resolution shall take effect upon the date of the
 10 adoption.
