BILL

AN ACT concerning

Collective Bargaining Agreement - Deputy Sheriff's Association of Prince George's County, Inc.

FOR the purpose of approving a labor agreement by and between Prince George's County and Deputy Sheriff's Association of Prince George's County, Inc., to provide for a wage increase and certain terms and conditions of employment for personnel classifications certified by the Prince George's County Public Employee Relations Board.

BY repealing and reenacting with amendments:

SUBTITLE 16. PERSONNEL.

Section 16-233(f)(14),

The Prince George's County Code

(1987 Edition, 1988 Supplement).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Section 16-233(f)(14) of the Prince George's County Code be and the same is hereby repealed and reenacted with the following amendments:

SUBTITLE 16. PERSONNEL.

DIVISION 19. COLLECTIVE BARGAINING.

Sec. 16-233. General.

- (f) The following collective bargaining agreements are hereby adopted and approved:
- (14) Declaration of Approval Deputy Sheriff's Association of Prince George's County, Inc.

The County Council of Prince George's County, Maryland, having fully considered the labor agreement concluded between Prince George's County and the Deputy Sheriff's Association of Prince George's County, Inc. on [June 3, 1988] April 3, 1990, hereby approves said agreement in accordance with the provisions of Section 13A-109 of the Prince George's County Code.

SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after the date it becomes law and that the provisions of the labor agreement shall be retroactively effective to the dates specified in the agreement.
