WHEREAS, under the terms of the Housing and Community Development Act of 1974, as		
amended, Prince George's County is qualified as an urban county eligible to receive its thirty-		
sixth year entitlement of Community Development Block Grant (CDBG) funds in the estimated		
amount of \$6,063,206	and \$190,000 in Program Income; and	
WHEREAS, as a federal requirement for the use of CDBG funds, project funding requests		
were solicited from the public through various means including conduct of a public forum; and		
WHEREAS, under the terms of the Cranston-Gonzalez National Affordable Housing Act o		
1990, as amended, Prince George's County is qualified to receive its nineteenth year entitlement		
of HOME Investment Partnerships (HOME) funds in the estimated amount of \$3,120,592 and		
\$280,000 in Program I	ncome for FY 2011; and	
WHEREAS, under the terms of the Stewart B. McKinney Homeless Assistance Act of		

1988, as amended, Prince George's County is qualified to receive its twenty-third year

entitlement of Emergency Shelter Grant (ESG) Program funds in the estimated amount of \$269,322 and must provide an estimated \$269,322 in matching funds; and

WHEREAS, as a condition to the award of the above-referenced funds, HUD regulations effective January 5, 1995, require Prince George's County to prepare and transmit to HUD a five-year Housing and Community Development Consolidated Plan: FY 2011-2015 (the "Consolidated Plan"); and

WHEREAS, the FY 2011 Annual Action Plan relies on estimates that are based on FY 2010 funding because the County's eligible funding for FY 2011 has not been announced by HUD; and

WHEREAS, the Consolidated Plan, adopted by CR-26-2010, was prepared following a detailed citizen participation plan, identifies and assesses housing and community development needs, incorporates a housing market analysis, and presents a strategic plan for addressing priority needs; and

WHEREAS, pursuant to Subtitle 15A of the Prince George's County Code, as amended, the County Executive transmitted a draft Annual Action Plan for Housing and Community Development: FY 2011, incorporating the grant applications and the County Council duly advertised and conducted a public hearing on the draft Annual Action Plan; and

WHEREAS, the County Council, in recognition of public testimony and on the basis of its review and analysis of the draft Annual Action Plan, finds that said Plan generally conforms to the provisions and intent of Subtitle 15A, as amended.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the draft "Annual Action Plan for Housing and Community Development: FY 2011," a copy of which shall be marked for identification by the Clerk of the County Council and maintained as a permanent record, is hereby approved, in accordance with the activities described in the FY 2011 Budget Summaries and the draft FY 2011 Annual Action Plan, Attachments "A" and "B", respectively, as attached hereto and made a part hereof.

BE IT FURTHER RESOLVED that the County Executive or his designee is hereby authorized and empowered as the official representative of Prince George's County to submit the approved "Annual Action Plan for Housing and Community Development: FY 2011" to HUD, along with all assurances contained therein, to act as necessary in connection with the submission, and to provide such additional information to HUD as may be required.
