**RESOLUTION**

1 A RESOLUTION concerning

2 Northern Gateway Expansion

3 For the purpose of expanding the Northern Gateway to include the new area of Buck Lodge in  
4 Councilmanic District 2.

5 WHEREAS, Prince George’s County is uniquely situated to attract and promote  
6 revitalization of longstanding existing development, particularly in the corridors and established  
7 neighborhoods of the County; and

8 WHEREAS, the northwestern quadrant of the County, with its eastern border at Adelphi  
9 Road, is composed of diverse neighborhoods that serve as a window into Prince George’s  
10 County; and

11 WHEREAS, the County Council finds that the designation of a uniform name for this  
12 particular area of Prince George’s County will serve to rebrand the area and help unify the  
13 diverse communities therein, while creating a stronger sense of connectivity for this area of the  
14 County that is experiencing a major demographic transformation; and

15 WHEREAS, the Council further finds that the designation of the name, Northern Gateway,  
16 will assist with the aforementioned benefits above, as well as serve as a catalyst for new  
17 reinvestment to further advance the revitalization that is underway in these areas, providing  
18 Prince Georgians with well-paying jobs, an increased tax base for County residents, and a better  
19 quality of life; and

20 WHEREAS, the Prince George’s County Council is committed to facilitating and  
21 supporting the revitalization of our established communities in the County.

1 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
2 County, Maryland, sitting as the District Council for that part of the Maryland-Washington  
3 Regional District in Prince George's County, Maryland, that the designation of the name,  
4 Northern Gateway, be given and the same is hereby established.

5 BE IT FURTHER RESOLVED that the Northern Gateway shall be composed of the  
6 geographic area generally bounded by the Prince George's County boundary line with  
7 Montgomery County to the northwest; the municipal boundaries of the City of Hyattsville and  
8 the City of Mount Rainier to the south; the Prince George's County boundary line with the  
9 District of Columbia and the City of Takoma Park in Montgomery County to the west; Adelphi  
10 Road to the east; and the new area of Buck Lodge that expands Councilmanic District 2.
