WHEREAS	, pursuant to Subtitle 15A-103 of the Prince George's County Code, as		
amended, the Co	unty Executive submitted a citizen participation plan in conjunction with the		
FY 2006-2010 C	onsolidated Plan for Housing and Community Development to the County		
Council; and			
WHEREAS	, the citizen participation plan was adopted by CR-41-2005 and provided for		
citizen involveme	ent in the various stages of Housing and Community Development activities and		
was amended by	CR-81-2005 to list the actions which are subject to the citizen participation		
plan; and			
WHEREAS	, pursuant to Section 15A-105(a)(2) of the County Code, the FY 2005,		
FY 2006, FY 200	07, FY 2008, and FY 2009 Annual Action Plans must be amended to include the		
estimated cost of	projects, the total cost to bring them to completion, and an identification of the		
sources of funds;	and		
WHEREAS	, Attachment "A" includes the projects within CDBG Program Years 31, 32,		
33, and 34 (i.e., FY 2006, FY 2007, FY 2008, and FY 2009) that have been approved for funding			

but must be restructured for completion; and

WHEREAS, Attachment "B" includes the projects within CDBG Program Years 30, 31, 32, 33, and 34 that were approved in a prior Annual Action Plan and that need to be reprogrammed and reallocated to existing and new activities.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the FY 2005, FY 2006, FY 2007, FY 2008 and FY 2009 Annual Action Plans for Housing and Community Development are hereby amended to restructure, reprogram, and add CDBG activities, as described in Attachments "A" and "B".

BE IT FURTHER RESOLVED that upon adoption of the Resolution, it shall be transmitted to the County Executive by the Clerk of the Council to submit the amended Annual Action Plans to the U.S. Department of Housing and Urban Development.
