It is my pleasure to submit to you and the County Council the appointment of Luisa F. Robles-Diaz-de-Leon and the reappointment of Mr. Charles Renninger to the Prince George's County Solid Waste Advisory Commission (SWAC).

Ms. Luisa F. Robles-Diaz-de-Leon, a resident of Greenbelt, is the Recycling/Sustainability Coordinator for the City of Greenbelt. She generates the City's greenhouse gas emission inventory and recommends energy reduction strategies.
