BACKGROUND INFORMATION/FISCAL IMPACT:

This resolution extends the operations of the Healthy Food in Prince George's County Correctional Facilities Task Force, originally established by CR-006-2024. The task force is responsible for reviewing and recommending improvements to food standards, procurement policies, and nutritional adequacy in county correctional facilities. This extension allows the task force to continue its work through November 30, 2027, and requires it to submit updated findings and recommendations by that date. all other provisions and reporting requirements from the original resolution remain unchanged.
