This Resolution directs the staff of the Prince George's County Planning Board of the Maryland-National Capital Park and Planning Commission to prepare, in accordance with the provisions of the County Zoning Ordinance, a minor amendment to an approved Development District

Overlay Zone in the County, namely, the 2004 *Sector Plan and Sectional Map Amendment for the Prince George's County Gateway Arts District* that will amend the Gateway Arts Development District Table of Permitted Uses to permit private or public multipurpose art center uses in the R-18 Zones of the development district, subject to public comment upon notice and public hearing on the proposed amendment at a joint public hearing to be held, in accordance with prescriptions of law, by the District Council and the Prince George's County Planning Board.
