**RESOLUTION**

1 A RESOLUTION concerning

2 The Redevelopment Authority of Prince George's County Fiscal Year 2021

3 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Redevelopment Authority  
5 of Prince George's County for Fiscal Years 2021-2026; prepared pursuant to the authority  
6 contained in Subtitle 15B of the Prince George's County Code; and providing comments on the  
7 proposed Operating Budget of the Redevelopment Authority for Fiscal Year 2021.

8 WHEREAS, Section 15B-124 of the Prince George's County Code provides that the  
9 Redevelopment Authority of Prince George's County may propose one or more projects for  
10 inclusion in the Redevelopment Authority's Capital Improvement Program; and that the County  
11 Executive shall transmit to the County Council for its approval by resolution or ordinance any  
12 such project approved by the County Executive; and

13 WHEREAS, the County Executive has proposed for approval five Capital Projects for the  
14 Redevelopment Authority's Capital Improvement Program which consists of project numbers  
15 8.90.0002 Addison Rd/Capitol Hts. Metro Corridor, 8.90.0004 County Revitalization, 4.90.0001  
16 Glenarden Apartments Redevelopment, 8.90.0003 Suitland Manor, and 9.90.0001 Cheverly  
17 Development, copies of which are attached hereto and incorporated herein by reference as  
18 though they were set forth fully herein, identified as Attachment 1; and

19 WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the  
20 proposed operating budget of the Redevelopment Authority includes any item to be funded from  
21 payments to be received from the County that the anticipated receipts shall be identified for each  
22 item and a copy of the proposed budget shall be transmitted by the Redevelopment Authority to

1 the County Executive and the County Council for their review and comment; and

2 WHEREAS, the Redevelopment Authority has forwarded its proposed operating budget to  
3 the County Executive and the County Council for review and comment as shown in the  
4 Appendix to the FY 2021 proposed budget, a copy of which is attached hereto and incorporated  
5 herein by reference as though it was set forth fully herein, identified as Attachment 2

6 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince  
7 George's County, Maryland, that subject to and in accordance with the authority of the Charter of  
8 Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the  
9 Capital Improvement Program for Fiscal Years 2021-2026 of the Redevelopment Authority of  
10 Prince George's County, as submitted by the County Executive to the County Council, is hereby  
11 amended, authorized, approved and adopted as reflected in Attachment 1.

12 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the  
13 proposed Fiscal Year 2021 Operating Budget of the Redevelopment Authority of Prince  
14 George's County and concurs with an Operating Budget of \$694,800 for the Redevelopment  
15 Authority, as reflected in Attachment 2.
