BACKGROUND INFORMATION/FISCAL IMPACT:

The County Council enacted CB-076-2013 for the purpose of defining Urban Farms and permitting the use in the R-18 Zone under certain circumstances. This legislation expands the definition of Urban Farms and also permits the use in additional residential zones with minimum lot sizes of at least one-half acre.
