I am writing on behalf of the Hyattsville City Council to respectfully request a postponement of the scheduled hearing in the matter of Detailed Site Plan 21001 entitled *Suffrage Point Lower lot* scheduled for February 26<sup>th</sup>, 2024. Given the complexity of this application, we require more time to thoroughly review the pertinent documentation.

We emphasize that this request is made in the interest of safeguarding the environmental impacts of this application, as we are charged to uphold principles of environmental stewardship within our city.
