Committee Vote: Favorable with amendments, 5-0 (In favor: Council Members Dernoga, Dean, Turner, Knotts and Harrison)

The Legislative Officer provided a summary of the bill and referral comments that were received. CB-40-2009 amends the County Code to relating to towing regulations and towing of vehicles from private property, establishes license fees and penalties and transferring certain responsibilities from the Police Department to the Department of Environmental Resources (DER). This legislation seeks to implement recommendations in the Towing Task Force Report issued in 2007.

Representatives from DER supported the bill and offered two amendments. Mr. Christopher Erdle, former Chair of the Towing Task Force, testified in support of CB-40-2009 in its entirety.

Additional testimony was presented by the representatives of the towing industry and the Apartment and Office Building Association of Metropolitan Washington in general support of bill but offering several amendments to the legislation.

The Committee had extensive discussions with all interested parties and accepted the several amendments as reflected in Draft 2.

The Office of Law determined that CB-40-2009 was in proper legislative form.

The Office of Audits and Investigation indicated there will be a positive fiscal impact in the amount of \$238,000 annually on the County as a result of adopting CB-40-2009.
