1 AN ORDINANCE concerning

2 Pet Grooming Shops

3 For the purpose of permitting Pet Grooming Shops in the L-A-C Zone under certain

12 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,

15 Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,
