For the purpose of adopting individual codes and standards of the National Fire Protection			
Association in accordance with Section 11-253 of the Prince George's County Code.			
WHEREAS, Section 11-253 of the Prince George's County Code identifies various codes			
and standards of the National Fire Protection Association to be adopted by resolution; and			
WHEREAS, the adopted Standards of the National Fire Protection Association form an			
integral part of the Building, Mechanical and Electrical Codes of the County.			
NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's			
County, Maryland, that the following enumerated codes, standards and model laws published by			
the National Fire Protection Association are hereby adopted and made a part of Subtitle 11,			
Division 4 of the Prince George's County Code in their entirety. The text of these adopted			
codes, standards and model laws shall be fully enforceable as if the same were incorporated and			
set forth at length therein. If any provision of the codes, standards, and model laws adopted			
herein, is less restrictive than the provisions of Subtitle 4 of the County Code, then the
