**BILL**

AN ACT concerning

**Parking Authority**

For the purpose of adding certain ex officio members to the membership of the Parking Authority, restricting the payment of compensation to citizen members of the Authority, and providing for a certain payment to the County's general fund.

BY repealing and reenacting with amendments:

**SUBTITLE 2. ADMINISTRATION.**

Sections 2-402 and 2-404,

The Prince George's County Code

(1991 Edition, 1994 Supplement).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that Sections 2-402 and 2-404 of the Prince George's County Code be and the same are hereby repealed and reenacted with the following amendments:

**SUBTITLE 2. ADMINISTRATION.**

**DIVISION 27. PARKING AUTHORITY.**

**Sec. 2-402. Membership.**

(a) The Authority shall consist of five (5) citizen members and two ex officio non-voting members. The ex officio members shall be the Chief Administrative Officer of the County or a Deputy Chief Administrative Officer designated by the Chief Administrative Officer and the Director of Public Works and Transportation of the County. The citizen

members [who] shall be residents of Prince George's County, one (1) of whom shall be selected from a list of three (3) nominees submitted by the Prince George's County Municipal Association. All members shall be persons who, in the judgment of the County Executive and the County Council, possess ability, experience and integrity. [Members] The citizen members shall be appointed by the County Executive for terms of four (4) years each and confirmed by the County Council. The terms of the appointments shall be staggered in such a manner that the terms of office of no more than two (2) members of the Authority may expire in the same year. Vacancies shall be filled for the unexpired term in the manner of original appointment. Each member shall serve until a successor is appointed and qualified even though the period of service may extend beyond the above four (4)-year term. All official acts and votes of any member during the period of extended service shall be valid as if the member were within said four (4)-year term. A member of the Authority may be removed only for malfeasance, misfeasance, neglect of duty or other good cause by the County Executive with the concurrence of the County Council.

(b) The County Executive shall designate two (2) citizen members of the Authority to serve as Chairman and Vice-Chairman.

(c) The citizen members shall be entitled to such compensation as is established in the annual operating budget of the authority, provided that such compensation shall be paid only for meetings actually attended.

**Sec. 2-404. Operating Budget of the Authority.**

(a) Each year, in accordance with the timetable required for the County's Current Expense Budget, the Authority shall submit to the County Executive its proposed Current Expense Budget for the ensuing fiscal year with estimates of its revenues and expenditures. Estimated revenues, which may include appropriations from the general fund of the County (including payments from the County under contracts or leases with the Authority or guarantees by the County of Authority bonds), shall be detailed as to source, and estimated expenditures shall be detailed as to program or project. All such estimates shall be submitted in such form and with such other supporting data as the County Executive or the County

Council may request. The Authority's proposed budget shall contain a statement of all revenue estimated to be received by the Authority during the ensuing fiscal year, classified so as to show the receipts by funds and sources of income; a statement of any debt service requirements for the ensuing fiscal year; a statement of the estimated cash surplus, if any, available for expenditure during the ensuing fiscal year; a statement of any estimated deficit required to be made up in the ensuing fiscal year; an estimate of the amounts which the Authority deems necessary for conducting the business of the Authority to be financed from (and not to exceed) estimated revenue for the ensuing fiscal year; a statement of the bonded and other indebtedness of the Authority; a statement of any proposed contingency reserve which shall remain unappropriated; a comparative statement of the receipts, amounts budgeted, and annual expenditures for the last completed fiscal year; the estimated receipts and expenditures recommended by the Authority for the ensuing fiscal year; a statement of all proposed expenditures for and estimated revenue from leases, subleases, and similar real estate transactions not identified in the capital budget of the Authority; the amount of contribution to the County's general fund as directed by the County Executive; as well as any other material which the County Executive or the Council may require.

SECTION 2. BE IT FURTHER ENACTED that when and if Article 41, Section 14-305 of the Annotated Code of Maryland is amended to so authorize, the ex officio members referred to in Section 2-402 shall become voting members of the Authority and the word "non-voting" shall at that time be deleted from Section 2-402 and of no further force and effect.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law and shall be retroactively effective to July 1, 1995.
