RESOLUTION

1 A RESOLUTION concerning

2 Fiscal Year 2026 Federal and State Transportation Grant Application Authorization

3 For the purpose of authorizing the Director of the Prince George’s County Department of Public
4 Works and Transportation (DPW&T) to file applications for Fiscal Year 2026 from entities
5 distributing Federal funding to include, but not be limited to those with the Maryland Department of
6 Transportation (MDOT) and its’ offices and modal administrations, including the Maryland
7 Transit Administration (MTA), the Maryland State Highway Administration (SHA) and the
8 Maryland Highway Safety Office (MSHO) of the Motor Vehicle Administration (MVA); the
9 United States Department of Homeland Security (USDHS); the United States Department of
10 Transportation (USDOT) and its’ offices and modal administrations including the Federal
11 Transit Administration (FTA) the Federal Highway Administration (FHWA), the Federal
12 Railroad Administration (FRA), and the National Highway Traffic Safety Administration
13 (NHTSA); the United States Department of Energy (DOE); the United States Department of
14 Agriculture (USDA), the United States Department of Housing and Urban Development (HUD),
15 the United States Environmental Protection Agency (EPA) and Washington Region’s
16 Metropolitan Planning Organization (MPO), the Metropolitan Washington Council of
17 Governments (MWCOG).

18 WHEREAS the Maryland Transit Administration (MTA) is the designated recipient in
19 Maryland for grants under the Federal Transit Act; and

20 WHEREAS MWCOG is the designated recipient for the Enhanced Mobility Program and the
21 Transportation Land-Use Connections Program grant; and

1 WHEREAS the Bipartisan Infrastructure Law grants under the Federal Transit Act; and
2 WHEREAS the USDHS is the designated recipient for the Transit Security Grant Program
3 under the Federal Transit Act; and

4 WHEREAS, the Administrator of the Maryland Transit Administration, the Administrator of
5 Maryland Highway Safety Office, the Administrator of Maryland State Highway Administration, the
6 Executive Director of the Metropolitan Council of Governments, and the Secretary of Homeland
7 Security are authorized to make grants to counties and local governments for mass transportation
8 programs and/or projects, respectively; and

9 WHEREAS, an application for financial assistance imposes certain obligations upon the
10 applicant, which includes a local share of the costs for certain projects and/or programs; and

11 WHEREAS, the USDOT, in accordance with the provisions of Title VI of the Civil Rights Act
12 of 1964, requires an application for assistance under the Federal Transit Act to give assurance that it
13 will comply with the Title VI of the Civil Rights Act of 1964 and the United States Department of
14 Transportation requirements thereunder; and

15 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
16 County, Maryland, that the filing of the aforesaid applications for Fiscal Year 2026 be endorsed.
