Committee Vote: Favorable 7-0 (In favor: Council Members Campos, Dean, Dernoga, Exum, Harrington, Hendershot and Knotts)

This bill will amend the labor agreement between the County and the Deputy Sheriff's Association (DSA) covering the period of July 1, 2005 through June 30, 2007. During the labor negotiations in 2005, the parties agreed by way of a "Reopener" to later negotiate the starting salary for the Deputy Sheriff Private (W21) effective July 9, 2006. The renegotiations affected steps A,B and C of grade W-21 of Salary Schedule W.

According to information provide by the Office of the Sheriff, 71 Deputy Sheriffs will be affected by this renegotiated salary schedule (52-Step A, 13-Step B and 6-Step C).

There will be a negative impact on the County as a result of enacting CB-87-2006 in the amount of approximately

\$265,220 for FY 2007.

BACKGROUND INFORMATION/FISCAL IMPACT:

The Deputy Sheriff's Association of Prince George's County, Inc., and Prince George's County, Maryland, during the 2005 labor negotiations, agreed to negotiate the starting salary for Deputy Sheriff Private later in 2006. This bill amends the labor agreement to reflect the changes to Salary Schedule W for Deputy Sheriff Private (W21), effective July 9, 2006. A fiscal impact statement will be provided by the Office of Management and Budget.
