10	SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
11	Maryland, that Section 3-101 of the Prince George's County Code be and the same is hereby
12	repealed and reenacted with the following amendments:

14	DIVISION 1. DEFINITIONS.
15	Sec. 3-101. Definitions.
16	(a) As used in and for the purposes of this Subtitle, the following words and phrases shall
17	have the meanings assigned to them herein:
18	* * * * * * * * *
19	(42) Farm Animal shall mean any domesticated species of animal commonly kept in
20	proximity to, but not ordinarily housed in the immediate domicile or household of, humans, and
21	used for agricultural or [riding purposes] equine activities. Farm animals shall include, but not

1	be limited to, horses, cattle, [domestic] domesticated fowl, sheep, and swine. Dogs and cats[,
2	that are companion animals,] are not farm animals.
3	* * * * * * * * *
4	(52) Livestock shall include all domestic or domesticated bovine animals, equine
5	animals, ovine animals, porcine animals, cervidae animals, capradae animals, animals of the
6	genus Lama, animals of the family camelid, ratites, poultry, and enclosed domesticated rabbits or
7	hares raised for human food or fiber [, except companion animals]. Companion animals are not
8	livestock.
9	SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five
10	(45) calendar days after it becomes law.
