The Enactment of a Certain Ordinance of the City of College Park	
FOR the purpose of approving the enactment of Ordinance 05-O-12 amending Chapter 87 of the	
City of College Park Code concerning fences.	
WHEREAS, the City Council of the City of College Park, after a public hearing conducted	

on October 19, 2005, enacted Ordinance 05-O-12; and

WHEREAS, this Ordinance (which is attached hereto and incorporated herein as Attachment A, and hereinafter referred to as the "Ordinance") amended the College Park Code Chapter 87, Section 87-23; and

WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code authorizes municipalities within the Maryland--Washington Metropolitan District to enact ordinances concerning fences on land either zoned for residential or commercial use or adjacent to residential or commercial zones for the purpose of preserving, improving and protecting the general character and design of lands within the corporate limits of the municipality, provided that such ordinances impose stricter or additional limitations or restrictions than are otherwise imposed by the County zoning regulations; and

WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that such ordinance shall not be effective until approved by the County Council of Prince George's County, sitting as the District Council; and

WHEREAS, the City of College Park, pursuant to Section 8-112.1 of Article 28 of the Maryland Annotated Code, has delivered a certified copy of the Ordinance to the District

Council; and 1 2 WHEREAS, the District Council has determined that the Ordinance imposes additional 3 conditions upon fences than those currently imposed by Subtitle 27 of the Prince George's 4 County Code (the "Zoning Ordinance"). 5 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's 6 County, Maryland, sitting as the District Council for that part of the Maryland-Washington 7 Regional District in Prince George's County, Maryland, that Ordinance 05-O-12 of the City of 8 College Park, as represented in Attachment A to this Resolution, be and is hereby approved.
