7	for an applicant starting on the date of violation.	
8	(c) The Maryland-National Park and Planning Commission and the Department of	
9	Permitting, Inspections and Enforcement shall not advise applicants that they may	
10	continue operating in the absence of or in violation of a use and occupancy permit.
