#### PUBLIC SAFETY AND FISCAL MANAGEMENT

**Date 10/27/2008**

Committee Vote: Favorable, 5-0, (In favor: Councilmembers Knotts, Campos, Dean, Exum and Turner.)

This resolution will amend the approved position by grade listing included in the Annual Budget and Appropriation Ordinance of the County for FY2009 (CB-28-2009). Section 815(b) of the County Charter provides that during any fiscal year, no agency of County government may exceed the number of positions in each grade for that agency as approved in the operating budget without prior approval of the County Council.

The amendments to the resolution will add the following:

1. Attachment A
  - a. One General Fund Administrative Specialist (G-29) to the County Council.
2. Attachment B.
  - a. Two grant funded positions (G18/21) to the Human Relations Commission.
  - b. Nine grant funded positions to the Department of Corrections.

c. Four grant funded positions and one General Fund Nurse Practitioner (G23/25) position to the Health Department.

d. Adjust the position by grade listing for nine General Fund and six other fund positions to reflect the Approved Budget.

A total of two additional full-time General Fund positions and 15 additional Limited Term Grant Fund (LTGF) positions are requested. The 15 LTGF positions are funded through grants.

The Office of Law has reviewed this resolution and finds it to be in proper legislative form with no legal impediments to its adoption.

The adopting of CR-95-2008 will not have a negative fiscal impact on the County.

This Resolution amends the Position by Grade Attachments (Attachments A and B) to Annual Budget and Appropriation Ordinance of Prince George's County for FY 2009 (CB-28-2008) to add one (1) full-time position for the County Council, one (1) full-time position for the Health Department, two (2) grant funded positions to the Human Relations Commission, nine (9) grant funded positions for the Department of Corrections and four (4) grant funded positions for the Health Department. Additionally, the resolution adjusts other position grades to reflect the Approved Budget.
