Old Marlboro High School (Historic Site 72-019-52)


## CR-72-2019

## MINOR AMENDMENT ONE:

Amend the 2010 Prince George's County Historic Sites and Districts Plan to remove the Old Marlboro Primary School, Historic Site 79-019-51, and the Old Marlboro High School, Historic Site 79-019-52, as described in Attachment A, and fully incorporated herein.

Notwithstanding any approval of this proposed Minor Amendment, the architectural plan shall be adjusted to incorporate the Historic character of the Town of Upper Marlboro. In addition, the existing Historical Cemetery on that site shall be preserved.



## Old Marlboro Primary School

#### Criteria cited in 2010 Historic Sites and Districts Plan

## CR-72-2019

### **Staff Analysis**

- The proposed Minor Amendment would remove all protection for the Old Marlboro Primary School and Old Marlboro High School buildings that they are currently afforded under Subtitle 29 of the County Code.
- The proposed Minor Amendment would not alter the environmental setting of the Dr. William and Sarah Beanes Cemetery Historic Site, which would continue to comprise the entire parcel unless and until it is revised by the Historic Preservation Commission.
- As such, any proposal to alter or demolish the two school buildings or construct a new building on the property would be subject to review by the Historic Preservation Commission unless the environmental setting of the Dr. William and Sarah Beanes Cemetery Historic Site is revised to exclude the part of the property on which the two school buildings now stand.

## Historic Preservation Commission Hearing September 16, 2019

- Staff briefed the HPC on the purpose of CR-72-2019 and its potential impact on the subject historic sites
- Public testimony received by the HPC was unanimously opposed to the minor amendment
- HPC found there was no evidence to determine that the Old Marlboro Primary School or Old Marlboro High School no longer met the historic site designation criteria of Subtitle 29-104(a)
- HPC voted 7-0 to recommend to the Planning Board and District Council that the minor amendment be disapproved

### **Analysis of Joint Public Hearing Testimony**

#### Main themes of supporting testimony:

- The property is well-suited for the proposed James H. Taylor Innovative Academy, which would serve at-risk youth
- Adaptive reuse of the existing buildings is not feasible

#### Main themes of opposing testimony:

- The minor amendment process has never been used to remove historic site designations
- CR-72-2019 does not specify what public planning objective would be advanced by approval of the minor amendment
- The property retains a high degree of historical significance; CR-72-2019
  does not address the criteria cited in the 2010 Historic Sites and Districts
  Plan or explain why the designations should be reevaluated at this time
- The Town of Upper Marlboro would like to acquire and redevelop the property through adaptive reuse of the existing buildings

## Planning Board Resolution 19-119 Adopted October 17, 2019

- Recommends that the District Council APPROVE the Minor Amendment to the 2010 Historic Sites and Districts Plan as contained in CR-72-2019
- Recommends that any proposal for redevelopment of the subject property seek to retain historic building fabric from the two school buildings to the extent practicable and to commemorate the history of the property through interpretive signage or other visual elements
- Recommends that the Dr.William and Sarah Beanes Cemetery (Historic Site 79-019-22) be preserved in place and protected from any redevelopment of the subject property, including through the delineation of an appropriate environmental setting
